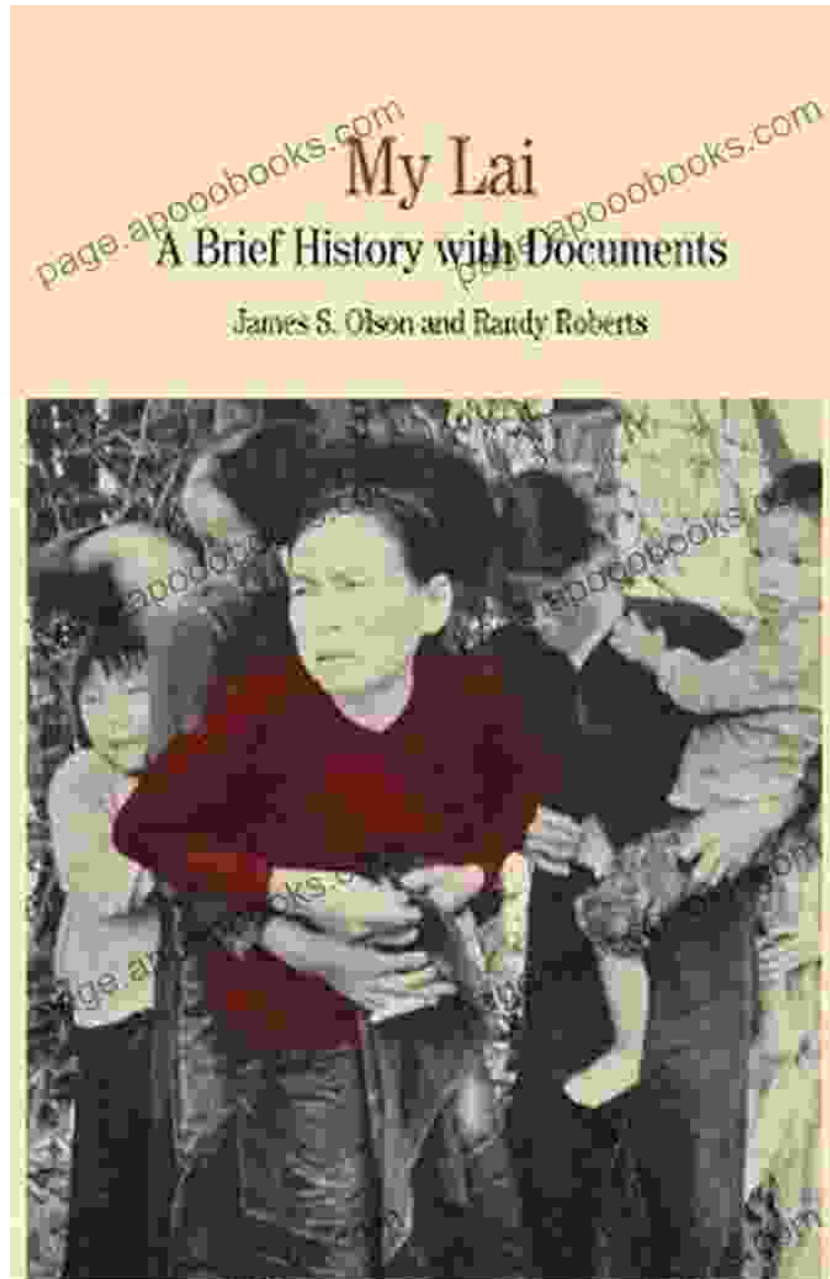
The Petition of Right: Asserting Parliamentary Supremacy

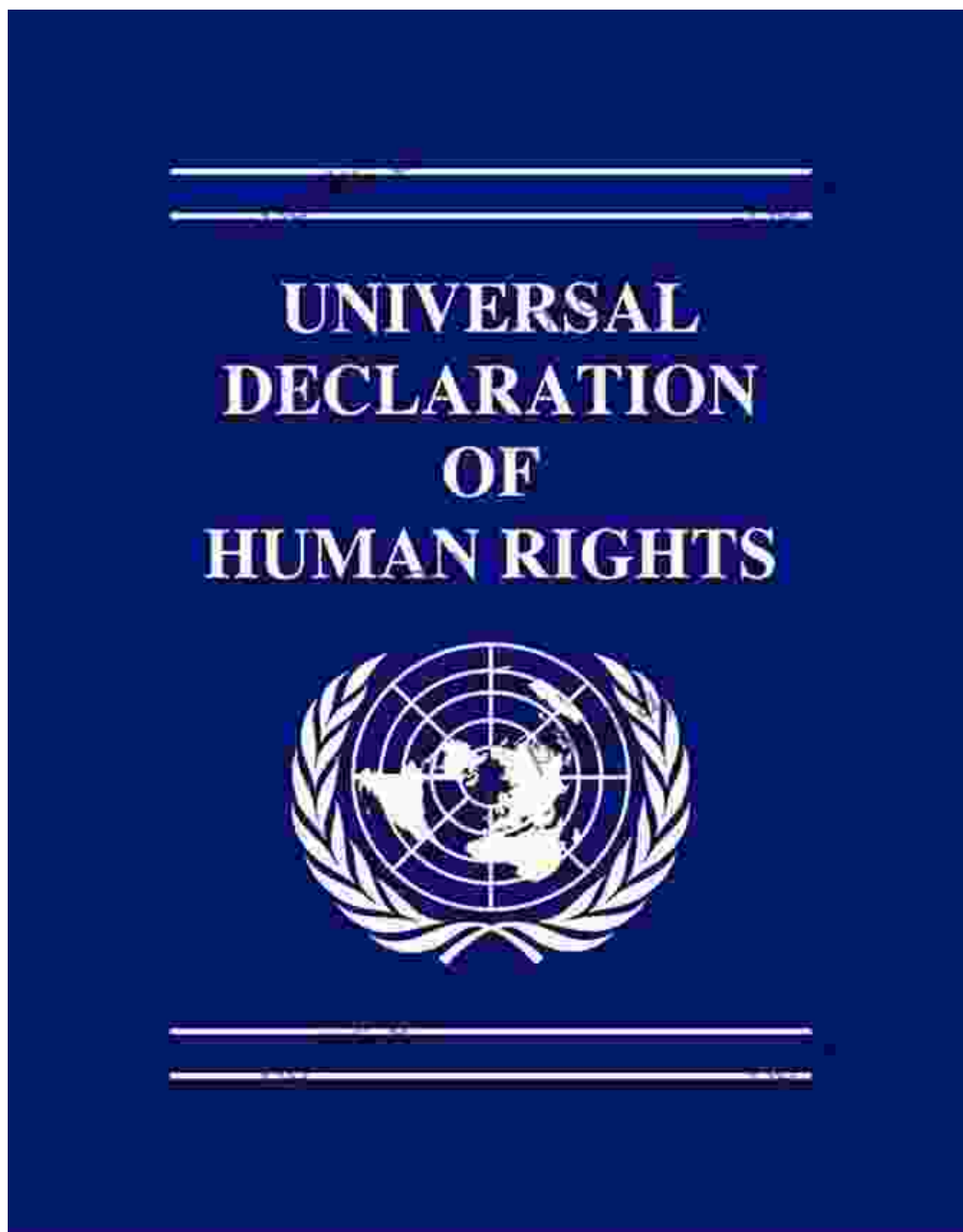
